## NOTICE

### **Cottonians' Social Responsibility (CSR):: A mentorship programme of the Undergraduate & Postgraduate Students of the University from the session 2019-20**

To establish a vibrant student-society linkage, a mentorship program entitled **COTTONIAN'S SOCIAL RESPONSIBILITY (CSR)** has been planned from the academic session of 2019-20. Under the CSR program, each student would be allowed to interact with the students of a chosen group in a primary/high school of their choice during his or her course of study. The broad objective of the students' interaction would be:

1. To tutor the chosen group of students of the school in the subject of their interest/ or the need of the school;
2. To initiate mini-projects involving specific local real-life problems like health related activity, environmental concerns, etc. Thereby encouraging the young minds towards an interdisciplinary approach;
3. To create awareness amongst the student community in maintaining the flora & fauna of their locality;
4. To make the students aware about social issues like judicious use of water, plastic, mobile phones etc.;
5. To create awareness amongst the village farmers about organic cultivation by use of bio-fertilizers & bio-pesticides.

The salient points of the program are:

1. The student can register himself/herself for the programme anytime after enrollment in a particular course of the University, but not during the last semester of the course.
2. The students would have to interact with the students for at least for 32 hours during the programme.
3. At the time of registration, the students have to fill up the enclosed form in duplicate which will be countersigned by HoD & Headmaster/ Headmistress/ Principal of the school (Form-I);
4. The Dean of the Faculty concerned would be responsible for the overall supervision and smooth implementation, monitoring of the program.
5. Students will update their activities in the student's portal of the University.
6. At the end of the project, a completion certificate in specified format has to be obtained from the Headmaster/Principal/ Head mistress of the school (Form II).
7. The concerned academic departments will access the grades of the CSR activity of its students.
8. The grades obtained would be reflected in the final grade sheet of the students.
9. A certificate, stating the details of the CSR program, would be awarded to the successful students at a suitable function in the University.

Monitoring the program through technological means, when carefully planned and properly executed, may enhance the social responsibility of the next generation in the society.
