Out of the aforementioned service experiences, at least two works must have been executed in Assam.	The bidder must have experience in execution of at least 2 (Two) works of supply, installation, testing & commissioning of D.G. Sets of the brand offered in this tender, having capacity not less than 500 KVA during last 7 (seven) years at any Govt. / Semi Govt. Departments or Autonomous Body supported by both work order and completion certificate from clients. Out of the aforementioned service experiences, at least 1 (one) work must have been executed in Assam.
