iii **Ration Card** issued by the Competent Authority. In case the students or their parents do not possess a Ration Card, then **Income Certificate** (whose parental income is below **Rs. 4.00 lakhs Rupees Four Lakhs per annum**) from Local Revenue Circle Officer can be submitted.

iv **Student' Declaration Form Duly Filled and Signed.**

v. **Proof of Minimum 75 % Attendance** in Classes in Previous Semester duly certified.

If either of the parents (mother or father) of the student is working in the State Govt./Central Govt./Semi Govt./State or Central Govt. undertakings, such student shall not be eligible under Fee Waiver Scheme.

Fee Waiver Scheme shall be applicable only to the students who get the above validated and submit the same to the Certificate Branch as per the mentioned dates and time.

Student must comply with the aforesaid time line. No late submission of documents for Fee Waiver and No Late Admission shall be entertained. **Process Window will be closed w.e.f. closing hours of the office on 25th July, 2026.**
